**Charity Checklist: Managing Legal Compliance Risks (9:00 a.m. – 12:00 p.m.) - \$25**

Ensuring compliance with the *Income Tax Act* can seem a daunting task, especially with competing mission-related priorities. However, ignoring your obligations can lead to embarrassment, penalties and worst of all, CRA revoking your charitable status. Join charity lawyer Mark Blumberg (editor of [CanadianCharitylaw.ca](http://CanadianCharitylaw.ca)) as he provides plain-language information, tools and resources about your legal compliance obligations. The workshop will cover:

- The top legal compliance concerns of your charitable registration;
- How CRA's new Guidance *Fundraising by Registered Charities* impacts your organization;
- Complying with your annual filing requirements (T3010B).

**Strengthening Governance, Ethical Standards and Financial Controls (1:00 p.m. – 4:30 p.m.) - \$25**

Charity lawyer Mark Blumberg will explore key governance, ethical and financial control strategies that will help safeguard your assets and prevent misuse of your organization's resources. This interactive workshop will cover:

- Your board's seven key legal responsibilities;
- The difference between qualified and non-qualified donees (and how this designation affects your dealings with partners in Canada and abroad ... to say nothing of your charitable status);
- Basic financial controls that will help protect your charity's assets.

**Who should attend these workshops:** Executive Directors, Board Chairs and Treasurers, Senior Managers, or the designated person responsible for completing your charity's information return (T3010B). NB - These presentations are suitable for both staff and/or volunteers of registered charities to attend.

**Cost:** Each session is \$25. If you stay for the day, your fee for both sessions (\$50) will include a networking lunch.
